- 3. Tile Flange A protective flange used in tiled walls to create a watertight seal around pipes.
- 4. Mixer Cartridge The internal component of a mixer tap that regulates water flow and temperature.
- 5. Cistern Tap & Hose A tap and connecting hose for toilet cisterns, ensuring proper water supply.
- 6. Cistern Inlet Valve Controls water flow into the toilet cistern, often with a float mechanism.
- 7. Shower Hose & Elbow Flexible hose and elbow joint for showers, allowing adjustable spray direction.
- 8. Shower Door Rollers Wheels that enable smooth sliding movement for shower doors.
